

## **DES MOINES DISC GOLF CLUB MEETING**

### **Quorum Established**

**Minutes of previous meeting:** Approved

### **Elections:**

1. Online voting didn't work, instead Corey used e-mail to present the ballot and receive votes.
  - a. 16 ballots were turned in
2. Results: President – Chris Greenleaf; League Director – Joe Wiley; Course Director – Tyler Sarg
3. Joe moved to accept elected board members, Corey second, voted unanimous yes.

### **Challenge Updates:**

1. Corey presented the idea of raising money through CFR discs
  - a. Joe, Shane and Tim all disliked the idea; idea tabled.
2. Ewing will be usable in the 2009 event as the construction will not start until after the Challenge.
3. Schedule options presented by Corey
  - a. 5 rounds by all pools with a final 9 at Walnut Ridge on Sunday
4. Option of having lunch included as part of entry presented by Corey
  - a. Options and viability will be looked into by Corey and First Class Credit union.
5. Got the OK to use Walnut Ridge for Finals (details in Walnut Ridge section of minutes)

### **Ice Bowl Update:**

1. Corey is ordering Ice Bowl Merchandise.
  - a. Long Sleeve t-shirts – 22 total (L – 4 of each color, XL – 4 of each color, XXL- 3 of each color)
  - b. Hooded Sweatshirts – 6 total (L – 1 of each color, XL – 1 of each color, XXL- 1 of each color)
  - c. 25 discs (10 DX Rocs, 5 Full Color Rocs, 10 Champion Boss)
2. Shane needs Volunteers
3. Shane asked if we are giving a basket away to whoever brings the most food
  - a. Jay moved that we buy a basket, Tim seconded, voted unanimous yes.
4. Everything will be the same as last year; location, time, and entry fee.

### **Affiliate Club Program:**

1. Joe needs a check for \$25 for the program through the PDGA; needs to send it out tomorrow.
  - a. Jay moved, Shane seconded, voted unanimous yes.

### **Storage Unit:**

1. We need to get everything moved to the new unit
  - a. Move will take place Sunday December 9, 2009 at 5 pm

**Website Update:**

1. Joe would like an easier way to sign-up for league
  - a. Corey looked into an online storefront through the current website; the cost is \$113.84 per year.

**Walnut Ridge:**

1. Corey and Shane meet with the Army Corps of Engineers
  - a. Got the Ok to use the park for the final 9 of the Challenge
2. The Army Corps is looking to shorten the season at Walnut Ridge by 4 weeks.
  - a. They would like the Club to volunteer for 2 weeks in the spring and 2 weeks in the fall to keep the park open; efforts would include emptying trash cans and cleaning restrooms
  - b. By doing so the park can maintain its current season and the Army Corps will waive special events fees for the club.
3. Shane is going to look into the issue of the missing signs at the park.
  - a. Shane is going to look into a way to better secure the signs.
  - b. If the Army Corps will not replace the signs the Club will have to use Ice Bowl money or host a fundraiser to replace them.
4. Scott Walsh sent in preliminary papers to the Army Corps to use the park for a Memorial Day weekend tournament; possibly using the tournament as a fundraiser for new tee signs.

**Big Creek:**

1. A meeting was held to discuss the use of the park during the winter months and issues with disc golfers disturbing the cross country ski trails.
  - a. The meeting took place without the Club being notified of the issue
  - b. Chris Greenleaf and Steve Nixt represented the disc golf community at the meeting.
  - c. Chris is going to work with Corey and the Cross Country Ski Club to create signage.

**Mac Rae Park:**

1. Plans are still in the works.
2. Shane is setting up a meeting to present 4 or 5 potential layouts for the park.

**Miscellaneous:**

1. Shane thanked Tim for his active participation as Club President over the past few years.
